## **Export Controls Designated Liaison Network–Update**

The University's Export Control Designated Liaison Network consists of TAMU offices with responsibility for administering components of TAMU's export control compliance program. The department/unit representatives coordinate with the Export Controls Office on export control compliance. Representatives from the AgriLife and TEES Export Control offices also participate. The group meets on a periodic basis to discuss export control issues of concern, ensure coordination of compliance efforts, assist each other on developing enhancements to existing processes and procedures, and to share training resources and best practices. Mr. Ray VanNorman (Raylandc@tamu.edu), the Director of the TAMU Export Controls Office (exportcontrols@tamu.edu), is the Facilitator of the Network.

In addition to representatives of TAMU offices with responsibility for administering components of the export control compliance program, faculty representation through the CPI was requested for the group. The faculty representatives do not serve as department/unit designated liaisons but do provide input to the group from a faculty perspective.

Some notes from the February 28 meeting:

- 1) Meeting was chaired by Lesa Feldhousen.
- 2) Department of Commerce Bureau of Industry and Security (BIS) had previously issued an Advance Notice of Proposed Rulemaking (ANPRM) requesting comments on criteria for identifying emerging technologies that are essential to U.S. national security. As an update, BIS received many comments, and several of those stressed the importance of maintaining the fundamental research exclusion; BIS plans to follow up with another ANPRM on "foundational technologies." BIS has not given a timeline for this; however, the Export Controls Office will update as they know more.
- 3) Committee on Foreign Investment in the U.S. (CFIUS) includes members of the Department of Defense, State, Commerce, and recently Homeland Security. They are authorized to review certain transactions involving foreign investment in the U.S. There is a pilot program that expands CFIUS' jurisdiction to cover additional transactions that it had no authority over previously. This includes minority investments by foreign persons in U.S. businesses that develop critical technologies in 27 designated industries. Their primary concern is to ensure that technology or funds from an acquired U.S. business are not transferred to a sanctioned country. The major change here is that previously, this was a voluntary review. Now, the review is mandatory if certain critical technologies are involved. CFIUS acknowledged that this process is still so new that they don't know the impact yet; however, hope to within the next 6-12 months.
- 4) Foreign Talent Program (FTP): On February 1, 2019, DOE announced a new policy prohibiting DOE federal and contractor personnel from participating in talent recruitment programs sponsored by countries determined by DOE to be seeking to exploit our scientific and technological expertise. It should be noted that while DOE has not clarified, there is a concern that "contractor personnel" may include grant recipients. The Export Controls Office will update as soon as this is clarified. DOD is also working to strengthen their policy on FTPs.
- 5) **Foreign Influence on NIH funded research**: NIH has expressed concern that some employees, including grant recipients, may be receiving benefits from foreign entities and not reporting them. HHS, OIG, DOJ, and the FBI are now looking into this issue.
- 6) Huawei Corporate Entities: Possible ban on specific equipment (certain 5G pieces).
- 7) **TAMU International Shipping Survey**: 115 responses were received. The Export Controls Office is reviewing the responses, and will identify ways to provide updated guidance to departments.
