#### **Travel Alert Related to Exporting Research Materials**

In light of recent situations involving researchers attempting to export research materials abroad, the Council on Governmental Relations (COGR) recently reminded its members that the FBI and other federal law enforcement agencies have increased their surveillance efforts to identify the transport of research materials and verify that those exports comply with federal laws. These efforts are believed to be part of a nation-wide enforcement action to control the transport of biological materials that may present a threat to our national security, and/or reduce the theft of intellectual property developed in the U.S.

Transporting certain materials may require import/export permits or other documentation from federal agencies, including US Customs and Border Protection (CBP), the FDA, USDA, Fish and Wildlife, and the CDC.



Individuals seeking to transport tangible material (e.g. biological materials, transgenic plants and animals, etc.) should seek guidance from the relevant university office(s) **before** transporting the research material to ensure that appropriate institutional approvals are in place.

#### Announcing NSF OIG Audit

On October 4<sup>th</sup>, 2019 the National Science Foundation (NSF) Office of Inspector General (OIG) announced that Texas A&M University will be undergoing an audit of NSF awards to examine expenditures posted to NSF awards for the period of October 1, 2016 through September 30, 2019. The NSF OIG has contracted with the audit firm Cotton & Company to conduct the audit at Texas A&M University.

Why is Texas A&M being audited? The OIG reports that there is not a specific concern that prompted the audit, it is not uncommon for universities to be audited on a rotating schedule. It's simply just our turn. What are the auditors examining? The auditors will be looking at expenditures posted on NSF awards during the period of October 1, 2016 through September 30, 2019. The auditors will be investigating details regarding the allowability and allocability of charges posted to NSF awards.

Examples of audit findings at other universities include but are not limited to:

- Untimely cost transfers
- Poorly documented/unsupported expenditures
- Purchases made at or near the end of the award period
- Purchases made after the end of the award period

- Timeliness and accuracy of effort reporting
- Travel charges for individuals who are not paid on the award
- Travel that does not clearly benefit the project
- Tuition and or fees should be prorated to match the % of appointment for students charged to the project
- Timeliness and accuracy of technical reports
- Timeliness and accuracy of financial reports
- Letter of credit draws
- Revenue recognition
- Close out

What does this mean for investigators/staff? Questions to investigators and staff by Cotton & Company will be coordinated through the Sponsored Research Services (SRS) office. As the audit progresses it is possible that a member from SRS may contact investigators or departmental staff to request documentation of expenditures, or additional justification regarding expenditures. It is *critical* to the success of the audit that if investigators or departmental staff receive questions from SRS, that timely and thorough responses are received. SRS will coordinate with the Division of Research (DOR) on formal responses to the contracted audit firm.

This is an appropriate time to remind investigators that the questions and clarifications sometimes made by the departmental staff, SRS or otherwise are to ensure that TAMU is following university and sponsor requirements.

We appreciate support from the Texas A&M research community throughout the audit process. We will provide updates periodically as the audit progresses.

# New Single IRB Requirement for Federally Funded Cooperative Research Goes into Effect January 20, 2020

-----

The 2018 Revised Common Rule requires federally funded studies that involve more than one institution to use a Single IRB when IRB review and approval is required. The effective date of the requirement is January 20, 2020.

Researchers expecting to receive a federal award in the near future for a collaborative research project that requires IRB review should contact the TAMU IRB to develop a plan to address the Single IRB requirement for that study.

All studies requiring Single IRB review will be routed through the TAMU IRB for the processing of institutional requirements prior to any Single IRB ethical review.

The Single IRB requirement applies to federally funded research and all research sites within the United States except when governed by American Indian or Alaskan Native tribal law or when the funding agency determines that the use of a single IRB is not appropriate.
