Discussions during the CPI-EC October meeting included the new student research assistant position job title being created for use. CPI-EC working collaboratively with the Student Financial and Employment Office, LAUNCH and Division of Research in creating a student research assistant position so research labs can continue to provide opportunities for Enhancing On-Campus Student Employment for undergraduates interested in working in research labs. CPI-EC members are working collaboratively with the Division of Research and Provost with concerns of faculty appointment time and faculty time-off. CPI-EC is currently working with the Office of Graduate and Professional Students and Sponsored Research Services in regards to payment and funding of graduate fees for TAs and RAs.

The CPI-EC continue to meet with President Young and Provost Fierke each month in order to keep PIs informed. The CPI-EC also meets with Chancellor Sharp every other month. Reminder: The November CPI General meeting will be Wednesday, November 13, 2019, Rudder 601, 11:30-1:15pm. Dr. Andy Morriss, Dean of the School of Innovation and Vice President of the Office of Entrepreneurship and Economic Development, will provide updates on both offices since their creation in 2017. He will detail the 9/1/19 transition of the Office of Technology Translation, the designated member commercialization office for Texas A&M University, to the Office of Entrepreneurship and Economic Development as Texas A&M Innovation Partners. This transition was the result of the multi-year review process for System Regulation 17.01 and created separate commercialization offices for the University and our state agency partners.

### **Federal Appropriations Update**

The end of the federal fiscal year is right around the corner (September 30th). What is Congress going to do? Here's what we know:

- As we reported last month, a continuing resolution (CR) is presently in play to extend the current FY19 funding levels through Nov. 21st, allowing the House and Senate time to negotiate a permanent spending deal.
- Last week the House easily passed the continuing resolution, H.R. 4378 (116), sending it to the Senate for consideration, where it is expected to pass later this week. The President has indicated he intends to sign the stopgap funding measure once it hits his desk.

We'll continue to monitor progress of the permanent 12 appropriations measures as the November 21st deadline approaches, and provide updates as appropriate.

#### **Engaging the Federal Government**

As a reminder, to assist with lobbying disclosure requirements, and to help make trips to Washington D.C. more strategic and effective: faculty, staff and students are encouraged to complete a brief online form prior to traveling to D.C.

### Biosafety Program to establish a Biosafety Compliance Network

The Biosafety Program provides support to researchers around the state of Texas including 18 cities outside of Brazos County. In addition to annual trips to those locations, the program is forming a biosafety network that will be composed of Biosafety staff and on-site safety and/or compliance representatives from local and remote locations to participate in online meetings quarterly. The long-term goal of these meetings is to establish a sense of cohesiveness among safety representatives by providing a platform for members to ask questions and clarify misconceptions regarding biosafety rules and regulations, to discuss commonly encountered biosafety related issues and share ideas for resolution, and to ensure that practices required to work safely with biohazardous agents are being implemented consistently in laboratories, vivaria, greenhouses, and insectaries. # Using PIVOT, a Funding Database Available Through the Library

### What is Pivot?

Pivot is a database of research funding opportunities provided to the TAMU community by the Texas A&M Libraries and the Vice President for Research. Pivot allows the research community with a mechanism for searching, saving, and being notified of research funding opportunities — based upon their research needs, areas, and profiles. It is a tool for use in diversifying possible funding agencies, and includes private foundations and other non-profit agencies that may provide opportunities for research funding.

OPEN to faculty, staff researchers, post-doctoral associates, and graduate students. It will only be offered virtually, via ZOOM, so you must register to obtain the zoom link.

### Pivot is a tool that:

- Provides access to a comprehensive database of global source of funding opportunities
- Pushes search results automatically to researchers via periodic email. Search results are guided by researcher profiles including keywords of interests and expertise.
- Enhances communication, monitoring, and tracking amongst individual faculty, teams, or researchers and the Research Development office through group notification functions.

**Webinar** training is targeted for researchers interested in developing a holistic strategy to advance from single Principle Investigator (PI) proposals to multi-PI proposals. Following a discussion of the potential pros- and cons- when considering a multi-PI proposal, discussing will be on best practices associated with planning complex, collaborative proposals. Other items from the webinar will include

- team composition and the development of team responsibilities
- Exploration on how proposal development teams can create strong multi-PI plans, to include rationale and justification for the approach, the organizational structure of the team, procedures for resolving conflict, and the decision making process.
- Examples of exemplary multi-PI plans and additional resources to help investigators determine if a multi-PI proposal is appropriate for individual career trajectories and will contribute to the success of a proposed project.

## Department of Energy (DOE): New Requirements that Govern Participation in Foreign Government Talent Recruitment Programs

On February 1, 2019, DOE issued a policy statement prohibiting DOE and contractor employees from participating in talent recruitment programs sponsored by countries determined sensitive by DOE. DOE issued an order formally implementing this policy on June 13, 2019 (DOE O 486.1). The order applies to DOE employees and contractors. ### National Institutes of Health (NIH): New Guidance on Other Support and on Policies Related to Financial Conflicts of Interest and Foreign Components

On July 10, 2019, NIH issued new guidance on Other Support and on policies related to Financial Conflicts of Interest and Foreign Components (see, NOT-OD-19-114, <a href="https://grants.nih.gov/grants/guide/notice-files/NOT-OD-19-114.html">https://grants.nih.gov/grants/guide/notice-files/NOT-OD-19-114.html</a>) The Notice includes a link to FAQs (see, <a href="https://grants.nih.gov/grants/faq-other-support-foreign-components.htm">https://grants.nih.gov/grants/faq-other-support-foreign-components.htm</a>).

## NIH Extends the Delay in Registering and Reporting Basic Research Studies in Clinical Trials.gov through September 24, 2021

On July 24, 2019, NIH issued a Notice (see, NOT-OD-19-126,

https://grants.nih.gov/grants/guide/notice-files/NOT-OD-19-126.html) delaying the time period for investigators to register and report their basic research studies on humans in ClinicalTrial.gov through September 24, 2021. The delay applies only to basic experimental studies with humans (see NOT-OD-18-212, https://grants.nih.gov/grants/guide/notice-files/NOT-OD-18-212.html). During the period of the delay, NIH continues to expect registration and reporting for studies submitted to Basic Experimental Studies with Humans Required FOAs, with additional flexibility to allow reporting on existing basic science portals, with the expectation that data will eventually be transported to ClinicalTrials.gov. Federal Acquisition Regulation (FAR): Prohibition on Telecommunications Equipment and Services from certain Chinese technology companies, in Government Contracts Department of Defense (DOD), General Services Administration (GSA) and National

Aeronautics and Space Administration (NASA) issued an interim rule which became effective on August 13, 2019 (see, <a href="https://www.govinfo.gov/content/pkg/FR-2019-08-13/pdf/2019-17201.pdf">https://www.govinfo.gov/content/pkg/FR-2019-08-13/pdf/2019-17201.pdf</a>). It implements a portion of section 889 of the FY 2019 National Defense Authorization Act relating to the prohibition on government procurement of any equipment, system or service that uses "covered telecommunications equipment or services" from certain Chinese companies, such as Huawei and ZTE. The interim rule defines "covered telecommunications equipment and services" to include any telecommunications equipment or services from Huawei or ZTE (or any affiliate) and certain video surveillance and telecommunications equipment or services from other Chinese companies (or their affiliates). It includes a new solicitation and contract requirement requiring a representation on whether or not the offer incudes covered telecommunications equipment or services.
