#### NSF PAPPG NSF 24-1 New Version Has Been Issued

NSF has announced that a revised version of the NSF Proposal & Award Policies & Procedures Guide (PAPPG) (NSF 24-1) has been issued. The new PAPPG will be effective for proposals submitted or due on or after May 20, 2024.

You can review the by-chapter Summary of Changes provided in the PAPPG. NSF will present information about these changes in a webinar on March 12that 2 PM EST. Sign up on the Policy Office outreach website to be notified once registration opens. While this version of the PAPPG becomes effective on May 20, 2024, in the interim, the guidelines contained in the current PAPPG (NSF 23-1) continue to apply. Changes that affect proposal preparation

- Biographical Sketch(es): This section has been revised to remove the 3-page limitation for the biographical sketch. There is no page limitation for this section of the proposal. The Synergistic Activities section has been removed from the biographical sketch. This information must now be submitted by individuals designated as senior/key persons as part of the senior/key personnel documents in Research.gov.
- Mentoring Plan: Proposals will require a mentoring plan for postdoctoral researchers or graduate students supported on the project. This page limitation for the Mentoring Plan remains one page.
- New checkbox on the Cover Sheet to indicate if there are "Potential Impacts on Tribal Nations." NSF will not award projects that may impact Tribal Resources or Interests unless the project has prior written approval from officials designated by the relevant Tribal Nations(s).

#### Texas A&M Innovation

The Division of Research announced a call for pre-proposals for the Advancing Discovery to Market (ADM) investment program which focuses on developing the commercial potential of new discoveries within the TAMU research enterprise. Learn more at the ADM website. Pre-proposals are due March 28, 2024.

Pete O'Neill, Texas A&M Innovation Chief Innovation Officer, will provide a seminar on April 17 to researchers with Research & Innovation, led by Dr. Ahmed Mahdy at Texas A&M University-Corpus Christi, on April 18 to researchers with Research & Innovation, led by Dr. Jose Espiritu at Texas A&M University-Kingsville, and on May 6 to researchers with Research Innovation & Economic Development led by Dr. Rupa Iyer at Tarleton State University. The sessions will include education on different forms of IP, patents, licensing, inventorship, and the benefits of commercialization. Email Texas A&M Innovation to request a workshop.

#### A&M System Guidance Regarding Non-Standard IP Review and Approval **Process**

On March 6, 2023, Chancellor John Sharp distributed a memorandum entitled "System Members' Authorization to License System Owned Intellectual Property" reiterating A&M System's ownership of intellectual property (IP) developed by faculty, staff and students employed by an A&M System member in accordance with existing A&M System IP policies and regulations (System Policy Series 17, Intellectual Property, and its related regulations). The memo notes that the Board of Regents has delegated to the Chancellor the responsibility for the management of such system-owned IP and that the Chancellor has delegated authority to the Vice Chancellor for Research (VCR) to execute legal documents and agreements relating to system-owned IP, including the licensing and assignment of such rights. Accordingly, all agreements, including sponsored agreements, that assign or license (grant right to use) system-owned IP to third parties require review by the Texas A&M Innovation office (TI) followed by OGC review for legal sufficiency and VCR approval (non-standard IP review and approval process), unless they fall within the following exceptions:

- 1. Agreements that grant a nonexclusive, royalty-free (NERF) license to new system-owned IP developed under the agreement only for non-commercial, internal research and development use:
- 2. Agreements that grant a license to use new system-owned IP under a grant or contract with the federal government (or under a federally-funded subcontract or subaward); or
- 3. Testing agreements if certain conditions are met.

Investigators should be aware that any agreement that waives ownership of or grants rights to systemowned IP and does not fall within one of the above three exceptions must undergo this non-standard IP review and approval process, which begins with a review by TI. If a non-standard IP review is required, the office negotiating the agreement (i.e., Sponsored Research Services or the member's research administration or contracts administration offices) will submit the agreement for such review and approval.

The FAQs will help investigators with questions about the Huron messaging system, PI Proxies, Primary Contacts, adding students and Adjunct/Affiliate personnel to studies and logging into the CITI website.

#### **Biosafety/Select Agent Program Updates**

#### **Proposed Changes to the HHS/CDC Select Agent Policies**

The Department of Health and Human Services (HHS) Centers for Disease Control and Prevention (CDC) has presented important policy changes regarding the HHS list of select agents and toxins. Those who work with biological select agents and toxins are encouraged to review the proposed policy changes and feedback as indicated in the Federal Register Notice by April 1, 2024 provide (https://www.federalregister.gov/documents/2024/01/30/2024-01513/possession-use-and-transfer-ofselect-agents-and-toxins-biennial-review-of-the-list-of-select-agents).

Below are highlights of the proposed amendments to the list:

- Removing three biological agents
  - o Brucella abortus, Brucella suis, and Brucella melitensis,
- Raising one toxin's exclusion amounts
  - Short, Paralytic Alpha Conotoxins,
- Renaming a virus
  - o Ebola Virus to the Genus Ebolavirus,
- Designating a current agent as a Tier 1 agent, and
  - Nipah Virus
- Removing the designation of Tier 1 status from one agent
  - Botulinum Neurotoxin Producing Species of Clostridium.
- HHS/CDC also proposes to clarify language and add requirements.

#### Guidance on Salary Limitation for Grants and Cooperative Agreements FY 2024

NIH NOT-OD-24-057, released January 29, 2024. The Consolidated Appropriations Act, 2023 restricts the amount of direct salary to Executive Level II of the Federal Executive pay scale. The Office of Personnel Management recently released new salary levels for the Executive Pay Scale. Effective January 1, 2024, the salary limitation for Executive Level II is \$221,900.

For active awards, including awards that have been issued in FY 2024 (continuation and new) that were restricted to Executive Level II, if adequate funds are available, and if the salary cap increase is consistent with the institutional base salary, recipients may rebudget funds to accommodate the current Executive Level II salary level.

#### NIH Enforcement of Unilateral Closeout Reporting in the System for Award Management

NIH NOT-OD-24-055, Released January 23,2024: NIH is strengthening enforcement of longstanding closeout requirements. NIH will report all unilateral closeouts of NIH awards as a Responsibility/Qualification (formerly FAPIIS) record in the entity's information in the System for Award Management (SAM.gov). Please be reminded that, without prior approval from the awarding institute or center for a delay in closeout, NIH will initiate unilateral closeout for all awards that fail to meet closeout requirements within 120 days.

The requirement for timely closeout is generally a recipient responsibility. However, NIH may initiate unilateral closeout if a recipient does not provide timely, accurate closeout reports or does not respond timely to NIH requests to reconcile discrepancies in grant records. In an effort to comply with the regulations, NIH will report unilateral closeout actions in SAM.gov retroactively, beginning with all unilateral closeout actions taken since January 1, 2023.

iThenticate is the leading provider of professional plagiarism detection and prevention technology used worldwide by scholarly publishers, funding agencies, and researchers to ensure the originality of written work before publication.

The Division of Research makes iThenticate available to TAMU researchers free of charge. Faculty are strongly encouraged to use the tool as a pre-submission check of papers, proposals, or any other document that will be made available to the broader research community. She still considers herself a neuroscientist first, and she still writes grant proposals.

#### BARBARA ENDEMAÑO WALKER, PH.D **DIRECTOR OF STRATEGIC RESEARCH INITIATIVES UNIVERSITY OF CALIFORNIA SANTA BARBARA**

Barbara Endemaño Walker is the Director of Strategic Research Initiatives at the University of California Santa Barbara (UCSB). She has a Ph.D. and M.A. in Geography from UC Berkeley and a B.A. in Anthropology and African Studies from UCLA. Her research and publications focus on broadening participation in higher education and STEM, and the gendered political ecology of marine resources in Ghana and French Polynesia. Her work has been funded by the National Science Foundation, the MacArthur Foundation, NOAA Sea Grant, the Social Science Research Council, and the Department of Education, among others. She serves on the National Science Foundation Committee on Equal Opportunities in Science and Engineering (CEOSE). She is also co-author of the book Funding Your Research in the Humanities and Social Sciences: A Practical Guide to Grant and Fellowship Proposals (Routledge 2017).
