Update from Dr. Robin Page, 2024-2025 CPI Chair

June CPI News – The Council of Principal Investigators Executive Committee (CPI-EC) met on Wednesday, June 4, 2025. Discussions during the CPI-EC meeting with the administrative leadership began with Dr. Diane Hurtado providing an update regarding the Nuclear Security Office here with Texas A&M University System. An update to the full CPI will be presented at the June 11, 2025 CPI General Meeting by Ms. Evelyn Mullen, Associate Vice Chancellor for Nuclear Security Initiatives.

CPI-EC held discussions with Mr. Adam Mikeal, Chief Information Security Office, Technology Services, Security and Risk at Texas A&M University regarding Cybersecurity Operations and Policy Updates for emails at TAMU and learned there are steps that can be taken to ensure PIs are sending and receiving emails. Mr. Mikeal will be sharing with the full CPI at the June 11, 2025, General Meeting.

CPI-EC welcomed and heard from Dr. Blanca Lupiani in her new role as Vice Provost for Faculty Affairs. She noted that she is committed to working with PIs and faculty in her new role and welcomes interaction and open communications with faculty and researchers.

Mr. Hardy will be providing a federal update at the June 11th CPI General Meeting. All PIs can continue to stay up-to-date on what is happening at the federal level by going to the Government Relations website [Home | Office of Government Relations](#) as well as seeing any recent Federal Policy Changes [Federal Policy Changes | Office of Government Relations](#).

All PIs are highly encouraged to communicate with their CPI representatives, <https://cpi.tamu.edu/council-membership/council-membership/2024-2025-council-membership/>, to bring forward items of concern or interest for the research community. The CPI Executive Committee continues to meet monthly with President Welsh, Provost Sams, interim Vice President for Research Georghiades, and other Texas A&M and System administrative leadership. I welcome thoughts, concerns, issues and agenda topics that impedes research efforts to all principal investigators within the research infrastructure within the Texas A&M University System. AI Steering Committee Update from Dr. Gang Han, CPI Representative

The overarching goal is for this committee to develop a strategic plan and vision regarding AI tools and resources available for research and teaching at the university by the end of this summer. An official communication, including multiple reports, will be distributed to all faculty members to solicit feedback. Dedicated working groups will prepare individual reports covering areas such as AI for interdisciplinary collaboration, AI literacy, ethics, governance, and AI tools in teaching and learning. Dr. Michael Johnson, Interim Vice Provost for Faculty Affairs, will review and finalize these reports. The announcement will also highlight the potential contributions of the NVIDIA SuperPod to the university's academic and research initiatives. Additionally, Mr. Ed Pierson, Vice President for Information Technology and Chief Information Officer, has indicated that his office is planning to conduct training sessions focused on the application of AI in specific research disciplines, including health sciences, chemistry, and engineering.

New Annual Malign Foreign Talent Recruitment Program Certification for PIs/co-PIs – June 7

NSF's new annual certification requirement for Principal Investigators (PIs) and co-Principal Investigators (co-PIs) regarding Malign Foreign Talent Recruitment Programs (MFTRP) starts on June 7, 2025. All PIs or co-PIs named on an NSF award made on or after May 20, 2024, must certify annually in Research.gov that they are not party to a MFTRP. Individuals who are currently a party to a MFTRP are not eligible to serve as senior/key personnel on an NSF proposal or on any NSF award made on or after May 20, 2024. NSF is providing notification of this new requirement to impacted PIs and co-PIs.

What you need to know about completing the required MFTRP certification in Research.gov:

- Impacted PIs and co-PIs will be prompted to complete the MFTRP certification after signing into Research.gov using the Sign In link at the top of www.Research.gov.
- PIs and co-PIs with more than one active award made on or after May 20, 2024, are only required to certify once, annually.
- Once completed, PIs and co-PIs can view their MFTRP certification response under the Academic/Professional Information section of their profile.

Responsible Conduct of Research

As outlined in [University SAP 15.99.99.M0.04](#), RCR training is required for students and postdocs participating in research. ALL students and postdocs participating in research are required to complete online [CITI RCR Training](#).

Additionally, externally funded graduate students and all postdoctoral fellows must complete four (4) hours of face-to-face (F2F) training. This training requirement can be met through the following F2F training opportunities:

ALL TAMU employees will be required to complete an annual Disclosure Profile and submit Pre-Approval Requests when necessary. We appreciate your support of this endeavor. While researchers have been doing this for several years, non-researchers can expect to receive notification from Huron indicating the required action.

Updated NIH Processes for No-Cost Extensions

NOT-OD-25-110 May 7, 2025 This notice alerts the extramural community that NIH has temporarily disabled the [No-Cost Extension functionality](#) in eRA Commons. The Director of NIH has directed NIH staff to review all existing grants and cooperative agreements to ensure that NIH awards do not fund off-mission activities or projects. Therefore, temporarily disabling the NCE functionality in eRA Commons will allow NIH staff to review and assess all NCE requests to confirm that the activities proposed during the extension align with the NIH mission and agency priorities.

At this time, all requests for NCEs must be submitted as a [prior approval request](#) in eRA Commons, for NIH review and approval. Requests for activities that do not align with the NIH mission and agency priorities will not be approved.

Human Research Protection Program Updates - Clinicaltrials.gov Account Requests

Clinicaltrials.gov account requests are on the rise, but there is still some uncertainty about posting requirements. Federal regulations (42 CFR Part 11:

<https://web.archive.org/web/20220615145059/https://www.ecfr.gov/current/title-42/chapter-I/subchapter-A/part-11>) require studies to be posted on the website when they:

- (1) Meet the definition of an Applicable Clinical Trial
- (2) Are a clinical trial funded by the National Institutes of Health (NIH)
- (3) Will be published in a journal that follows the International Committee of Medical Journal Editors' (ICMJE) policy

Please send an email to irb@tamu.edu to set up your individual Clinicaltrials.gov account. Include your institutional contact information and department name. A Texas A&M account administrator will send your login name and temporary password within 48 hours. Please note that your Clinicaltrials.gov organization name is TexasAMU. Animal Welfare Updates – Animal Use Protocol Closeout

The Animal Welfare Office (AWO) reminds all Principal Investigators (PIs) to formally close any approved animal use protocol (AUP) before leaving the institution. To initiate closure, PIs may either email the AWO directly or submit a Final Report of Expiring AUP through iRIS. Before requesting closure, PIs must ensure that no animals remain under the protocol. This process should also be followed when a project concludes and the AUP is no longer required. Living Wage Support Program Extended Through FY25

Since June 2024, the Divisions of Research, Finance, and Health have provided supplemental funding to support employees brought up to the new living wage, including those funded by sponsored research or other university accounts. This support program is now extended through August 2025 for individuals on the original list who remain in active payroll status.

Looking ahead to FY26, colleges must coordinate any continued funding requests. Colleges are strongly encouraged to review and identify internal funding sources to support eligible individuals wherever possible. If no funding can be secured at the department, college, or PI level, a formal request may be submitted to Annette Shenkir at ashenkir@tamu.edu. Requests must include the individual's name, UIN,

department, the amount or percentage requested (not to exceed the original percentage), and a brief justification explaining why internal funding is not available.

Dependent Care Grant for Research Program

The Division of Research remains committed to supporting Texas A&M University faculty and their participation in professional research meetings. Faculty with active sponsored research projects are eligible to apply for the Dependent Care Grant for Research Program. This program offers small grants—up to \$1,000 per fiscal year—to help offset additional dependent care expenses incurred due to professional travel. Requests are accepted on a rolling basis.
